Declaration of consent by the principal investigator's new research institution

With regard to that part of the research project (see above) which concerns the research institution under my direction, I hereby consent to the performance of said research at my institution and declare that the institution's entire infrastructure will be made available to all persons involved in the project. The research institution fulfils every prerequisite (structural aspects, power supply, climate control, etc.) for installing and operating the equipment requested in the present research proposal.

The researchers working on the project described in the proposal have the right to publish any scientific works resulting from the project in their own name. Restrictions with regard to publication date are possible if earlier publication would be prejudicial to novelty, but three months after results have been communicated to the research institution, no further restrictions apply. If the employer elects to take up the results, this period can be extended until the results have been adequately protected. The employer is obliged to apply for this without culpable delay.

The principal investigator alone decides how the project funds paid out to the research institution will be used. Transfers from the FWF to the research institution are made exclusively upon the request of the principal investigator.

Any FWF-funded project staff employed at the research institution shall work exclusively on the project to the extent of their employment. The principal investigator assigns these employees their tasks and is the only person authorized to issue instructions for work on the project. No instructions will be given to the project staff from the research institution that contradict their work on the project or hinder the implementation of the project in any way.
